


BUILDING THE FUTURE OF TRANSPORTATION

ABOUT VIA RAPID SERVICE

VIA Rapid will help move more people faster and farther with updates to lanes, sidewalks, traffic signals and bus stops. Improvements will enhance safety and traffic flow for everyone traveling in the corridor.

Set to open in 2027, the **VIA Rapid Green Line**, will connect employment and residential areas from near the San Antonio International Airport, along San Pedro Avenue, through Downtown and to the Missions area.






